CHICKEN PERMIT APPLICATION REQUIREMENTS

TWO SETS OF THE FOLLOWING INFORMATION MUST BE PROVIDED (ONE ORIGINAL AND ONE COPY)

- APPLICATION MUST BE FILLED OUT
 COMPLETELY & CLEARLY. Name and address must be on each document.
 Signature of property owner or applicant is required.
- 2. <u>DRAWINGS</u> Detailed drawings to include (but not limited to):
 - a. PLOT DRAWING- drawn to scale with the use of a survey map, if available showing the following:
 - Location of all existing structure(s) on the property
 - ii. Location of water supply (well or water line)
 - iii. Location and configuration of septic disposal system or sewer line
 - iv. Location of proposed pen, coop, or house including setbacks from property lines.
 - v. Location of fence (if applicable)
- BASIC REGULATIONS Please refer to Chapter 58 - Keeping of Chickens for all rules and regulations
 - a. No More Than 6 Chickens
 - b. No roosters shall be allowed

- Setbacks All pens, coops, or houses maintained for the keeping of chickens shall comply with the rear and side yard setback requirements
- d. **One Enclosure** one enclosure for the keeping of chickens. All structures limited to the Rear yard.
- e. **Enclosure construction** Must safely and securely house chickens and shall be kept free of rodent infestation at all times.
- f. **Run spacing** -There shall be no less than ten (10) square feet per chicken in any chicken run
- g. On permitted premises -Chickens shall be confined at all times to the property on which they are kept, possessed or maintained.
- h. No Resale -Any chickens maintained, housed or possessed and all eggs produced from said chickens shall be for the sole use and consumption of the homeowner or tenant in possession and shall not be offered for resale. No person shall engage in chicken breeding or fertilizer production for commercial purposes.
- 4. Fee as per fee schedule (Collected when application is approved.
