The fees, as property of the Town of Moreau, will be deposited into the general fund of the Town of Moreau and, periodically, an equivalent amount of said fees deposited will be returned by the Town of Moreau to the Emergency Squad for additional compensation for providing ambulance services in the Town of Moreau. Reed Antis asked if the Town Board received the Moreau Emergency Squads 990 form for 2015. He stated that the last one available on the website is from 2014. He stated that it would give the Board better information on their spending. Steve VanGuilder stated that the Town Board has seen the audit but that he didn't know about the 990. He stated that it didn't come from himself. Mr. Antis recommended that all members of the Town Board see the 990, which is public.

Mr. Antis asked if the Board is working with 911 to see how many squads are on call. He stated that the Squad is supposed to let 911 know who's available. Councilwoman LeClair stated that it was requested years ago and they were told it had to be requested by the Supervisor. Mr. Antis asked the Supervisor if he would request the information. Councilwoman LeClair stated that if an emergency squad doesn't correctly

let 911 system know how many ambulances are available and they get toned out, there would be a wait time. She stated that they're toned out twice before the call is given to mutual aide. If the 911 system knows that there is only one squad available, they would automatically tone out to the next available agency. Steve VanGuilder stated that when they get activated, there's an initial activation which shows how many ambulances they have, which is 4. The first two of the emergency response vehicles are staffed either with paid or volunteer. He explained how the procedure works and also stated that less than 1% of their calls go to mutual aide. Mr. VanGuilder stated that if there is no response after 3 minutes, they get toned out a second time and if no response after 5 minutes, mutual aid gets called. Mr. VanGuilder stated that they don't report anything to 911. Councilwoman LeClair asked how they would know how many ambulances are available and Mr. VanGuilder replied that they know they have 4 ambulances and that they're staffed with either paid or volunteer.

The Supervisor asked Mr. VanGuilder to supply the Town with the 990 report. Mr. VanGuilder stated that he would contact Jeff Beecher and get a copy for the Town. Mr. VanGuilder stated that he hates these problems and that every year its constant. Councilman Kusnierz stated that he has never been denied any information that he's requested from the Moreau Emergency Squad. Councilman Kusnierz also commented that less than 1% for mutual aid is an exceptionally low number. He knows of other municipalities that have to wait 30-40 minutes for the same level of care. He stated that he's very happy with the exceptional service of the Emergency Squad.

The Public Hearing remained open through the South Glens Falls Fire Company Public Hearing, which started at 7:03 p.m.
