SUBJECT: ADOPTION OF LOCAL LAW 1 OF 2017, AMENDING CHAPTER 130, TAXATION TO EXTEND COLD WAR VETERANS EXEMPTION

WHEREAS, the Town Board of the Town of Moreau ("Board") is considering the adoption of Local Law No. 1 of 2017, which would, if adopted, amend Chapter 130, Taxation, of the Code of the Town of Moreau to add new subsection 130-9(C) to provide for an extension of the Cold War Veterans Exemption to qualifying owners of qualifying real property for as long as they remain qualifying owners without regard to the ten (10) year limitation in accordance with New York State Real Property Tax Law Section 458-b; and

WHEREAS, the Board finds that in order to provide for the health, safety and welfare of Town residents and property owners, and in the best interest of the future of the Town, it is necessary to amend Chapter 130 to add new subsection 130-9(C) to provide for an extension of the Cold War Veterans Exemption to qualifying owners of qualifying real property for as long as they remain qualifying owners without regard to the ten (10) year limitation in accordance with New York State Real Property Tax Law Section 458-b; and

WHEREAS, the Board finds that the adoption of Local Law No. 1 of 2017 is in the best interests of the Town and is necessary to protect the health, safety and welfare of the residents and property owners to add new subsection 130-9(C) to provide for an extension of the Cold War Veterans Exemption to qualifying owners of qualifying real property for as long as they remain qualifying owners without regard to the ten (10) year limitation in accordance with New York State Real Property Tax Law Section 458-b; and

WHEREAS, the Board finds that the adoption of Local Law No. 1 of 2017 is a necessary and proper exercise of authority by the Board; and

WHEREAS, the authority for the enactment of this local law is found in Section 10(1)(i) of the Municipal Home Rule Law; and

WHEREAS, pursuant to Section 20 of the Municipal Home Rule Law, a public hearing on the proposed adoption of Local Law No. 1 was properly noticed in the newspaper and posted, and was duly conducted on November 14, 2017 at 6:45 p.m. at the Town Municipal Complex, and

WHEREAS, the Board has considered the public comments made at the public hearing; and

WHEREAS, the Board, serving as lead agency for this Unlisted action under SEQRA, reviewed a short environmental assessment form and determined that the action does not present any adverse environmental impacts; and

WHEREAS, after thorough review and deliberation, the Board proposes to adopt Local Law No. 1 of 2017; and

WHEREAS, the Attorney for the Town has prepared the necessary documents for filing this local law with the Secretary of State including the text of the law itself;

NOW THEREFORE, BE IT RESOLVED, that the Board hereby adopts Local Law No. 1 of 2017, annexed hereto, amending Chapter 130 to add new subsection 130-9(C) to provide for an extension of the Cold War Veterans Exemption to qualifying owners of qualifying real property for as long as they remain qualifying owners without regard to the ten (10) year limitation in accordance with New York State Real Property Tax Law Section 458-b; and

BE IT FURTHER RESOLVED, that the Board adopts and authorizes the filing of a negative declaration; and

BE IT FURTHER RESOLVED, that the Board hereby authorizes the Town Clerk and the Attorney for the Town to make such minor modifications to the local law documents as they deem necessary and thereafter are directed to execute and file the said documents as required by law and to take all the necessary action for the promulgation thereof.

OLD BUSINESS

The Supervisor stated that he had nothing new to report on the curb cut.

PUBLIC COMMENT PERIOD

Reed Antis asked how the Town handles Code Enforcement. He asked if it was Mr. Dreimiller's responsibility or Mr. Martin's. The Supervisor stated that it's a joint effort depending on the violation. Councilman VanTassel stated for the record that Matt Dreimiller was hired as Building Inspector/Code Enforcement Officer. He also mentioned that it has been a great joint effort between Mr. Dreimiller and Mr. Martin.

Mr. Antis stated that there is a bumpy ramp at the far end of the sidewalk and asked if this was a handicapped accessible ramp. He stated that all it lacks is a sign. He asked if it could be posted. The Supervisor stated that he thought handicapped individuals would rather pull right up to the door and thought the ramp should be closer. He also commented that this is part of a long list of shortcomings that the Town Board has had to deal with. Mr. Antis suggested putting up a sign for now, so that the spot can be used as handicapped parking, until they get a curb cut.

Mr. Antis asked if it would be legally possible for the Highway Department employees to switch their hours on December 6th and come in later, so they wouldn't have to pay overtime for the Stormwater training class. Councilwoman LeClair stated that their hours are regulated by the union contract.

Harry Gutheil, Mayor for the Village of South Glens Falls presented to the Town Board a concern over the SCA tax certiorari case. There was a very lengthy discussion over what information the Village should be entitled to. The Mayor commented that he didn't feel the Village was being adequately defended. Councilman Kusnierz stated, that without having intervenor status, if information were given to the Village, it would break the attorney client privilege and they would also have to release the same information to any other member of the public who might request it. Attorney Buettner expressed her concern over the discussion of negotiations in open session. The full audio of the discussion can be heard on the Town's website.

COMMITTEE REPORTS

Councilman VanTassel reported that the CSEA contract states that its employees would receive Christmas Eve and Christmas Day as paid holidays. It also states that if a holiday falls on a Saturday, they would receive the Friday off and if it falls on a Sunday they would receive the Monday off. Christmas falls on a Monday so it's unclear as to what day they would take for Christmas Eve. Councilman Prendergast asked what their preference is. Councilman VanTassel stated that they didn't indicate a preference but that he could ask. He stated that they were looking for direction.

A motion was made by Councilman VanTassel and seconded by Councilwoman LeClair to ask the CSEA union which day they would prefer to take for the Christmas Eve holiday (Friday before the weekend or Tuesday following Christmas Day) and authorize them to take that day based on their wishes.

Councilman Kusnierz stated that Counsel and the Building Department have been looking into how engineering inspections are being performed in developments. Attorney Buettner stated that she had conversations with Jim Martin a number of times over the concern of over engineering. She stated that not only does the developer's project engineer have to sign off but the Town's designated engineer has to sign off as well. She stated that it's becoming costly to the developers. She stated that they are looking at the laws in a few towns (Bolton and Lake George), to change the Town of Moreau law to say that the project engineer can sign off. She stated that they would have to be a P.E. in order to sign off on inspection reports. She stated that at the end of the project, the maps are certified by the P.E. and given to the Town. She stated that she and Jim Martin are both on board to address this within the next few meetings.

Councilman Kusnierz reported that he will be meeting with the Building Department on Thursday to discuss this in greater detail.

Councilman Prendergast asked Attorney Buettner if she would look into the Zombie Property legislation and asked what the Town will need to do to address some of these properties. Attorney Buettner stated that she thought she had sent a memo to the Board and will try to resurrect it. She stated that the law is not as broad as one would like, she stated that it's very specific. She stated that she would look into the matter and let the Board know what should be done. Councilman Prendergast commented on how some buildings are decaying. Attorney Buettner stated that the Town has a nuisance abatement law that was prepared but never adopted.

The Supervisor stated that there is now a school out in front of the Town Hall and asked the Board if they would want him to send a letter to DOT requesting a speed limit reduction. He didn't think that 30 mph would be unreasonable. He stated that he would contact Head Start to send a joint letter. Councilwoman LeClair suggested the use of flashing lights that indicate how fast you're going.

A motion was made by Councilman Kusnierz and seconded by Councilman Prendergast authorizing the Supervisor to submit a joint request for a speed limit reduction from 55mph to 30 mph on Route 197 between Route 9 and Route 32.

RESOLVED, that the Town Board hereby authorizes Bartlett, Pontiff, Stewart and Rhodes, P.C., Karla Williams Buettner, Esq., Attorney for the Town, to sign the appropriate Consent Order and Judgment resolving these matters.

Councilman Kusnierz stated that the Board did not take this decision lightly. He stated that they've worked on this for 2 ½ years and have expended 10's of 1,000's of dollars in professional fees and attorney fees to get to this decision. He stated that the Board does risk assessment and risk management. He stated that there was significant exposure for the Village with a potential for refunds. The decision was based on professional advice from appraisers, that they couldn't sustain assessed values on these properties, that they currently are at. They could have taken the risk and gone forward but might have had to pay refunds in over \$225,000 from the Village, plus interest and over \$650,000 from the School, plus interest. He stated that the Town would have to refund \$7,000.00 plus interest. He stated that this isn't a perfect outcome. He suggested, that from the standpoint, that no entity except for the School will have to pay refunds, this is a pretty good outcome for the parties involved. He stated that collectively as a Board, they felt this decision was in the best interest of the community, both for the School District, the Village and the Town, to settle.

Councilwoman LeClair stated that the Board is making a tough choice but feels that this decision is a correct choice.

Councilman VanTassel echoed the comments by Councilman Kusnierz and Councilwoman LeClair. He stated that there were a lot of hours spent in executive session and most of the focus was on the tax payers. He stated that with the advice of the experts and appraisers, he felt the numbers were fair. Councilman VanTassel also stated that the appraiser was well accredited.

Councilman Prendergast stated that he knows everyone labored over their decision for a long time. He stated that everyone here has struggled for months. He stated that some sort of decision had to be made.
