RAIL FEASIBILITY STUDY

The Supervisor stated over the years that they have had interest for businesses to go in the Industrial Park. He said once the prospective businesses were told there was no rail access they were no longer interested. He stated the Saratoga County Industrial Agency has requested a resolution from the Town Board of the Town of Moreau, that we favor them to fund the study of the rail access.

The Deputy Town Clerk read the following resolution:

MOREAU RAILROAD STUDY RESOLUTION

WHEREAS, the Town of Moreau would like to determine the potential economic and financial impact that may be derived from restoration of the railroad lines leading into the Moreau Industrial Park and up to the Essity paper manufacturing plant, as well as the impact it would have on the Town's job retention and creation opportunities and growth of industry in the Moreau Industrial Park, and how a reinvigorated railroad line might support stability and expansion of existing companies along the line; and

WHEREAS, the Saratoga County Industrial Development Agency owns the railroad right-of-way into the Moreau Industrial Park and up to the Essity paper manufacturing plant and could be the catalyst for retention of existing jobs as well as for additional job creation; and

WHEREAS, the Saratoga Economic Development Corporation has potential projects for the Moreau Industrial Park with interest in utilizing the railroad for transportation of raw materials and finished products, thus reducing a significant volume of commercial truck traffic on state, county and town roads and thereby reducing the deterioration of roads by removing a significant amount of traffic on such roads; and

WHEREAS, Saratoga Economic Development Corporation is working to retain jobs at other companies along the railroad route, and has surrendered multiple attraction prospects to bordering counties with rail access to industrial zoned sites; and

NOW, THEREFORE, BE IT RESOLVED that the Town of Moreau Town Board hereby requests that the Saratoga County Industrial Development Agency hires a company as soon as possible with the background and ability to study the economic and financial impacts a reinvigoration of the railroad line would have on the Town of Moreau and Saratoga County.

SANDBAR BEACH FACILITY GRANT

The Supervisor stated there was some good news on this grant. Pete Olesheski had applied for the grant and shepherded through the progress, which led to the success of an award of \$9,767.00. He stated that the Glens Falls Foundation would be pleased to have recognition with any publicity when doing this project. They would also like a report of the expenditures of the grant funds. The Supervisor would like to thank Mr. Niles on the award of the grant to the Town of Moreau. He would also like to thank the Recreation Department for submitting the grant application.

MOREAU SPEED LIMIT LEGISLATION

The Supervisor stated that he has met with Senator Jordan's office and Assembly member Woerner's office regarding the possibility of introducing to Legislation a resolution that would allow the Town of Moreau to set the speed limits of Town roads, streets and highways at their own discretion. The Town Board is aware that it is not uncommon for the Department of Transportation to deny a speed reduction request.

REQUESTING PASSAGE OF S.7374 (JORDAN)/A.9124 (WOERNER) EMPOWERING THE MOREAU TOWN BOARD WITH THE DISCRETION TO SET SPEED LIMITS ON CERTAIN TOWN ROADS

WHEREAS, the Town of Moreau faces unique challenges regarding traffic safety and, accordingly, would like to have the ability to control speed limits on Town roads, streets and highways, and the Town has received multiple requests over the years from residents seeking appropriate reductions in speed limits in or near their neighborhoods that were denied approval by the New York State Department of Transportation; and

WHEREAS, the Town Supervisor has reached out to Senator Jordan and Assemblymember Woerner to request sponsorship and introduction of Home Rule legislation permitting the Town of Moreau to determine the speed limits on Town roads, streets and highways; and

WHEREAS, legislation that provides the relief sought by the Town was introduced by Senator Jordan (S.7374) and Assemblymember Woerner (A.9124) during the 2020 Regular Session, entitled, AN ACT *relating to giving the Moreau Town Board the discretion to change speed limits*, a copy of which is annexed hereto* and incorporated herein by reference;

NOW, THEREFORE, BE IT RESOLVED that the Town Board of the Town of Moreau states its unanimous support for S.7374/A.9124 introduced during the 2020 Regular Session of the Legislature, and requests and urges its passage; and it is further

RESOLVED, that the Town Supervisor is authorized and directed to take all steps necessary to support the said proposed legislation S.7374/A.9124 including, but not limited to, execution and delivery of a Home Rule Request.

The Supervisor wanted to talk about the situation at 325 Old West Road where there the hairpin turn is. He has been down there several times talking to residents. He has also been down there a few times with the Highway Superintendent Paul Joseph. Most recently he has talked to the homeowner and asked what the Town could do to make it safer there. He stated that there isn't enough right of way to put up partial guardrails in that area. He stated that he asked the homeowner if they wanted to give the Town the right of way to put the guardrails partially on their property but that was not an option. This would require a hold harmless indemnification agreement with the property owner. It would be needed because the Town will be placing those boulders on private property. The homeowner, Matthew J. Caul of 325 West River Road, has agreed to that also. This would be executed by the homeowner.

CABLE FRANCHISE AGREEMENT

The Supervisor stated that he had a meeting with the Cable Franchise about the telecommunications. The Town had an agreement that expired in 2006. In the agreement there was language about buildout. It was twenty homes per buildable mile before they installed infrastructure at their cost. At the Public Communications website, it's now thirty-five homes per buildable mile. The Supervisor stated that he had pressed upon the representative, that some parts of the Town are in the agricultural district, and there would never be buildout at their cost. The representative graciously agreed to keep the term at twenty homes per mile. The representative will be reviewing where there is no cable access in the Town and report back to us.

COUNCILMAN DONOHUE TRAINING REIMBURSEMENT

The Supervisor stated that they had received a voucher from Councilman Donohue for a Training Conference he attended for newly Elected Officials. The total fee for the conference and gas mileage reimbursement is \$341.80.

SUPERVISOR'S ITEMS

The Supervisor stated that he will be attending, and will be a part of a presentation, of the Association of Towns annual meeting, to be held on Monday, February 17, 2020 in New York City. One of the engineers from the Laberge and himself will be presenting "Build It and They Will Come". Also, part two of the presentation "Chicken and the Egg", Economic Development and Infrastructure Development. They will be using the Town of Moreau as a case study.

The Supervisor stated that the Assessor, Leah Cronin, will start interviewing applicants for the Board of Assessment Review Board. He stated, that if any Board Members would like to sit in on the interviews they can. He stated that there can't be more than two at a time though, as that would be considered a meeting of the full Board. They have received four applications for two spots that need to be filled.

The Supervisor stated, that along with being Town Supervisor, he has been appointed a Board Member on the Saratoga County Prosperity Partnership, on the Saratoga County Water Authority, on the Unity, Veterans, Law & Finance, and on the Racing & Wagering Committees.

He stated that they had their first Veterans committee meeting and wanted to comment on a few of the highlights from it. The Veteran population in Saratoga County is 17,508. This ranks Saratoga County 12th largest in the State of New York. He stated that he would like to periodically recognize a living Veteran in

the Town of Moreau. Councilwoman LeClair stated this is a wonderful idea. Councilman Noonan stated that he was approached a while ago by a resident, who wanted to have the Town do flags of the Veterans with their pictures on them. The resident stated that there is funding to do this from a private group. They would like to know how to go about doing this in the Town of Moreau.

COMMITTEE REPORTS

Councilman Noonan stated, that a while ago, they had talked about the revamping of the Town logo. He realized that it was a bit more difficult than he had expected. He thinks the best thing to do is engage the services of an outside company and design team to take our ideas and design a more up to date logo. Supervisor Kusnierz stated that they should be able to fund the cost. He stated that he would investigate it and see what account they could use to pay for the expense.

Councilman Donohue stated that Councilman Hogan and himself will be meeting with the Adirondack Glens Falls Transportation Council on Thursday February 13, 2020. They will talk about some issues with one of the Town's roads and will report back next week about their meeting. Supervisor Kusnierz stated he is on the Board of the Glens Falls Transportation Council, they have a meeting Wednesday February 12, 2020. He stated if Councilman Donohue has any concerns, he can forward them to him, and he can bring them to the meeting. The meeting is at 10:00a.m.

Councilman Donohue also stated, that Ted Monsour from the Transfer Station, had asked about having a hazardous waste section at the Transfer Station. Supervisor Kusnierz stated that the County funds this for Towns. They usually pick 2-3 Towns and rotate them around the County. Any County resident can participate in the program.

PRIVILEGE OF THE FLOOR

Dominic Tom of Cedar Lane stated that he was disappointed with the inaction of the burned down house on Reservoir Road. The concern was raised about this is the summer of 2019. He also stated that this is not the only decrepit property in Town, that has been allowed to remain standing. He feels these properties are affecting the surrounding homes property values.

Councilman Donohue wanted to apologize for speaking over others at the previous Town Board meeting.

There was a brief discussion between the Supervisor and Councilman Donohue regarding the accepting of campaign funding and the process by which residents' concerns are brought to the Board for discussion. It was noted by the Supervisor that the Board's decisions are made in best interests of the residents and are made by a consensus.

A motion was made by Councilwoman LeClair and seconded by Councilman Noonan to adjourn to executive session for the purpose of discussing an unnamed employee's work performance at 8:30 p.m.
