The Supervisor stated that the Governor had announced last night, that New Yorker's age 60 and over will now be eligible for the COVID-19 vaccine, while public facing essential workers from governmental and nonprofit entities will be eligible beginning March 17. The Supervisor encouraged everyone who is eligible to sign up for the vaccine. He also stated that there is a Saratoga County interest list, which is available through the County's website. He stated that the County has sent out notices to its residents with information about the vaccine and there is also information on the Town of Moreau's website.

COMMUNITY DEVELOPMENT BLOCK GRANT RFP – 2020

The Supervisor stated that there were only two proposals received for the 2020 Community Development Block Grant. One from Laberge Group and one from C.T. Male Associates. The information was provided to the Supervisor's office on March 8, 2021. He stated that the Board members haven't had much time to review the proposals and asked if they wanted to table discussion until they've had a chance to review the documents. Councilmember Noonan stated that he would like some time to review the documents before they take action. The Supervisor tabled this agenda item.

SEWER DISTRICT PROPOSAL

The Supervisor stated that they've been trying to get the Town's water and sewer districts consolidated. He stated that it's been a challenge over the years with all the districts that have been formed. In relation to sewer, he stated that the Town's agreement with the City of Glens Falls will expire in June and as part of the contract negotiation process, the Town will need to know how much reserve capacity they'll need for long term operations. He stated that there was a problem in that it was unclear if some of the water and sewer districts were properly established. It was because of this, the Supervisor stated that he asked the Laberge Group to provide a proposal for professional services, so the Town can see what they have for legally documented established sewer districts and extensions. Also, to look at our current use and what the potential use may be. The Supervisor read the scope of the services that Laberge Group listed in their proposal. The lump sum fee is not to exceed \$35,600, excluding typical reversal expenses for travel. Laberge Group estimated that the Map, Plan and report would take 4-6 weeks, following authorization to

proceed. The Supervisor stated that this would follow in the same footsteps as what they're trying to do with water consolidation.

Councilmember Donohue asked about a hazardous waste day. The Supervisor stated that he would look into this through the County.

COMMITTEE REPORTS

Councilmember Hogan stated that the Recreation Leader had been in contact with the Boy Scouts. They're looking to do a butterfly exhibit at the Park and utilizing some of the wood that BOCES has taken out. They're looking for permission from the Town Board to go ahead with the project. The exhibit would be in the area between the playground and the tennis courts and shouldn't cost more than \$1,000.00. The Supervisor asked if this was for an Eagle Scout project and Councilmember Hogan replied that it was. Town Board members were okay with the project.
