Mr. Antis asked about Moreau getting its own zip code and asked how they should proceed on this. He thought that Councilwoman LeClair was going to contact Malta and find out who the person was that started the process of them getting their own zip code and how they went about it.

Mr. Antis asked about the abolition of reference to the Fernwood area.

Supervisor Jenkins stated he would put it on the agenda for the June 23rd meeting.

HIGHWAY DEPARTMENT REQUESTS:

The Highway Superintendent submitted a purchase request to the Town Board of his intent to purchase asphalt concrete under Saratoga County Contract 09-PWAC-3R. There are funds allocated in the amount of \$260,000.00 in DB5112.4923.4. He was requesting to expend the full allocation of \$260,000.00.

Steve Barody explained that the asphalt was going to be used in the reconstruction of Reservoir Road and Redmond Road. He expected there would be about \$6,000.00 left out of the \$260,000.00 after these two projects.

A motion was made by Councilman Cumm and seconded by Councilwoman LeClair authorizing the allocation of funds in the amount not to exceed \$260,000.00 out of account DB5112.493.4 for paving of Reservoir Road from Burt Road to Fort Edward Road and all of Redmond Road.

RECREATION DEPARTMENT REQUESTS

The Recreation Director submitted quotes for the installation of 200 amp underground electrical service from an existing Niagara Mohawk utility pole #6-6 to pavilion #4 in the Rec. Park. Quotes were as follows:

Town employees buried the cable.

Councilwoman LeClair stated that at a meeting of the Recreation Commission it was discussed about the need for bathrooms and a concession stand for the Little League Field and Fields 1, 2 and 3. It was recommended that when this electrical service was being put in we have them lay a wire in the ground to this area so when the day comes and electrical is needed in that area the wire will already be there.

Supervisor Jenkins stated that this wouldn't be part of this contract and Councilwoman LeClair replied, no, but she would like to see it done at the same time.

Steve Gram said he would take care of it.

Councilwoman LeClair reported that there are several areas in the Rec. Park where there are plantings that are becoming overgrown and crowded and some of them need to be cleared out. If some are cleared out of each area then some of the plantings will stand a chance to grow. She stated that she would put this information in Councilman Kusnierz's mailbox.

TOBACCO FREE RECREATION PARK AND BEACH

Supervisor Jenkins read a resolution that if adopted would prohibit the use of tobacco including cigarettes in the Harry J. Betar Jr. Recreational Park and the Town Beach.

A brief discussion followed on this resolution and Councilman Cumm asked if there would be any areas of the park or beach where tobacco use would be allowed and Supervisor Jenkins replied no. Councilwoman LeClair at first thought the public should have a chance to comment on this before it was adopted. Supervisor Jenkins was of the opinion that it is a policy that would protect the health of those who use our facilities. It isn't good to have someone smoking in close proximity to children who are playing in the area. Where there is tobacco use there are cigarette butts all around on the ground.

Steve Gram was in agreement with the ban.

Supervisor Jenkins stated that it is not a law rather a policy and doesn't require a public hearing.

Councilman Cumm noted that Gavin Park has a similar policy.

A motion was made by Councilman Cumm and seconded by Councilwoman LeClair adopting the following resolution:

WHEREAS, the Town of Moreau ("Town") owns and operates the Harry J. Betar, Jr. Recreational Park in the Town; and

WHEREAS, the Town, by virtue of an agreement with the Village of South Glens Falls, occupies the Sand Bar Beach ("Town Beach") and makes the Town Beach available for recreational use by the public; and

WHEREAS, the Town has exclusive operation and maintenance rights to the Town Beach; and

WHEREAS, the Town of Moreau Town Board ("Town Board") believes that tobacco use including cigarette use in the proximity of children and adults engaging in or watching outdoor recreational activities at the Harry J. Betar, Jr. Recreational Park and Town Beach is detrimental to their health and can be offensive to those using such recreational facilities; and

WHEREAS, the Town Board desires to create and sustain an environment that supports a no-tobacco use standard through a tobacco-free policy at the Harry J. Betar, Jr. Recreational Park and Town Beach; and

WHEREAS, cigarettes and chew products, once consumed in public spaces, are often discarded on the ground requiring additional maintenance expenses, diminish the beauty of the aforementioned recreational facilities and pose a risk to toddlers due to ingestion; and

WHEREAS, the Town Board has determined that the prohibition of tobacco use at the Harry J. Betar, Jr. Recreational Park and Town Beach serves to protect the health, safety and welfare of the citizens of Moreau.

NOW, THEREFORE BE IT RESOLVED, by the Town Board, that the following tobacco-free policy for the Harry J. Betar, Jr. Recreational Park and Town Beach is adopted.

SECTION 1: TOBACCO USE PROHIBITED AT THE HARRY J. BETAR JR. RECREATIONAL PARK AND TOWN BEACH.

The Harry J. Betar, Jr. Recreational Park and the Town Beach are hereby designated as non-smoking properties. No person shall use any form of tobacco at the Harry J. Betar, Jr. Recreational Park and the Town Beach including any structures located in these recreational facilities.

SECTION 2: NOTIFICATION.

Appropriate signs shall be posted in the above specified areas.

The community, including facility users and Town staff, will be notified of this policy.

SECTION 3: COMPLIANCE.

All individuals are expected to comply with this policy.

SECTION 4: EFFECTIVE DATE.

This policy statement is effective immediately upon the date of adoption.

TREE REMOVAL – REYNOLDS CEMETERY

There is a very large tree in Reynolds Cemetery that is in danger of falling and if it does it would take out several headstones and it needs to be cut down. High Peaks Tree Service has a contract with the Town for removal of trees and stumps in town right-of-ways and they quoted \$500.00 to remove it.

Councilwoman LeClair suggested they call Richard Sears Tree Experts for a quote and Councilman Cumm added in that they should also call Adirondack Tree Surgeons and Hunts Tree Care for quotes.

PLANNING BOARD APPOINTMENTS

Councilman Cumm stated that there are two openings now on the Planning Board. There are two candidates Keith Osborne and Erik Bergman. At the last meeting he and Councilman Prendergast said they couldn't make up their minds about which candidate to appoint and it was suggested that they both be interviewed again. Now that there are two openings he contacted Councilman Prendergast this morning and Councilman Prendergast is full heartedly in support of appointing both of them to the Planning Board.

Councilman Cumm made a motion to appoint Keith Osborne and Erik Bergman as members of the Planning Board. Councilwoman LeClair seconded the motion.

Supervisor Jenkins asked if anyone wished to be heard.

Adele Kurtz asked the Board if they interviewed the candidates at 6:30 p.m.

Councilwoman LeClair stated that they were going to hold interviews when we were going to pick one out of the two. When we discussed the two Councilman Cumm and Councilman Prendergast both talked about what excellent candidates both applicants were and what a difficult decision it was. LIQUOR LICENSE RENEWAL APPLICATION – HUMBUGGS

The Town Clerk received on June 2, 2009 by certified mail return receipt requested a liquor license renewal application from Keith Champagne D/B/A Humbuggs Food & Spirits to sell alcoholic beverages at Humbuggs located at 569 Gansevoort Road in the Town of Moreau.

Home Depot is going to be there and provide a wood crafting class for children. Children's museum awareness is going to be set up there and there will be a veteran's and military recognition.

Steve Gram reported on the last Recreation Commission Meeting. They discussed use of the subdivision rec. fees. They recommended the purchase of land. They also suggested that a concession stand for the Little League field be built and blacktop for around the quad.

Supervisor Jenkins said it appears they are on the same wave length of the Board. The land purchase is in negotiations. They will have to look into the cost of paving and if the highway department can help with this. As for the bathrooms and concession stand we would need a design and cost. The other question would be on the west side of the park the parking lot and if we are going to expand that and if so there is some drainage that we would need advice on. We should have funds to pave the handicapped area and the areas where stone exists.

[Councilman Kusnierz arrived at 8:05 p.m.]

Councilwoman LeClair stated that they talked about bathrooms between the soccer field and little league field. She also stated that Steve Gram should not be the general contractor on the job and Keith Kreppein offered to be general contractor.

Councilman Cumm stated they were trying to put the finishing touches on the Outdoor Wood Burning Furnace Law and he asked Adele Kurtz if she got any information to Joe Patricke and she replied no. He said that she was talking about putting some stuff together for that and he asked her if she planned on doing that. She replied yes, but she has been busy working on the Re-Zoning Committee. She thought it would be helpful to have a strike through and highlighting in the document so they know what has been stricken and what has been added. She stated that if they wanted to move ahead on it without her comments that would be fine. It was just that she was the only one there at the workshop. Joe Patricke didn't attend and legal counsel wasn't there so she took notes. If somebody wants to take them from the minutes that was fine. Councilman Cumm stated that we are moving along with the moratorium so we need to get something done.

Councilman Kusnierz asked what information we have to give to Joe.

Joe Patricke said she doesn't have to do anything. She was at the workshop and he wasn't and she offered to share her notes.

Adele Kurtz stated she should be able to get the information to Joe by next Wednesday.

Supervisor Jenkins stated that at the June 23rd meeting they should be able to schedule a workshop or public hearing.

SUPERVISOR'S ITEMS

Supervisor Jenkins stated that Terry McGuire is having problems with her computer and it ruined the Microsoft Front Page program that she uses to update the website. The computer purchased recently for Fran Thibodeau cost a little over \$700.00. He asked if the Board wanted to approve an amount up to \$800.00 for a new computer for Terry.

A motion was made by Councilwoman LeClair and seconded by Councilman Cumm authorizing the purchase of a computer for the Supervisor's Office for Terry McGuire to use at a cost not to exceed \$800.00.

A regular meeting of the Town Board of the Town of Moreau was held on June 9, 2009 in the Town of Moreau Office Building, 61 Hudson Street, South Glens Falls, New York.

Councilman Kusnierz asked how they were going to pay for this.

Supervisor Jenkins stated there is \$1,100.00 in A1220.2 (Supervisor's equipment account).

Attorney Auffredou stated that he and Joe Patricke needed to discuss the Pilot Travel Center with the Board. He said that as the Board is aware, Pilot has been before the Planning Board and at the last meeting the Planning Board asked Joe to contact Mr. Peter Faith a Traffic Engineering Consultant with TVGA to assist the Planning Board with their review of this project. TVGA submitted a proposal in the amount not to exceed \$9,500.00. The Planning Board has a scoping session coming up Monday, June 15th and it is important to get Peter Faith and TVGA on board so they can attend the Planning Board Meeting on June 15th. It would be paid out of Trust & Agency. He reviewed the proposal and he advised Joe Patricke that we should do a standard form contract with TVGA and have the Supervisor sign it. He apologized for not asking for this to be on the agenda. However, he was asking the Town Board to authorize the Supervisor to enter into an agreement with TVGA to assist the Planning Board with the engineering review of the Pilot Travel Center Project for a fee not to exceed \$9,500.00 with TVGA being paid out of Trust & Agency. This means that Pilot will put the funds up for these fees.

Councilman Kusnierz said that Attorney Auffredou doesn't need to apologize. It isn't his role to bring this to the Board.

Attorney Auffredou stated he felt he did, because he should have let the Supervisor's office know that he was going to be talking about this.

Councilman Kusneirz asked if we have anything in writing from the Planning Board that requests that the Town Board seek this out.

Attorney Auffredou said he didn't know how it works procedurally. He believed it was in the minutes that they wanted Joe to contact Peter Faith. It was his understanding of the law that the Planning Board Chair can enter into contracts on behalf of the Board.

Councilman Kusnierz said he was aware of the law, but was there a formal request?

Attorney Auffredou didn't think so. The Planning Board asked Joe to contact Mr. Faith. Mr. Faith submitted a proposal and that proposal was forwarded to him. He advised Joe based upon the proposal that we ought to have a contract between the Supervisor on behalf of the Town and TVGA.

Councilman Kusnierz thought that we usually seek out several quotes for professional services.

Attorney Auffredou replied yes, but this will be paid out of Trust & Agency and we have a track record with Mr. Faith.

Councilman Kusnierz thought it was unfair to the person who puts funds in Trust & Agency if we just sign a contract without seeking other proposals.

Attorney Auffredou said it may be, but his experience in representing developers in other Towns is that the Towns don't get proposals they go with whoever they want to go with and the developer has to pay.

Supervisor Jenkins stated isn't it a Planning Board decision anyway?

A regular meeting of the Town Board of the Town of Moreau was held on June 9, 2009 in the Town of Moreau Office Building, 61 Hudson Street, South Glens Falls, New York.

Attorney Auffredou said technically under the law the Planning Board can bind the Town Board to whatever they want to bind the Town Board to, but he didn't want to get into that.

Councilman Cumm stated that he didn't believe that Pilot would object to this since their time line would be disrupted and they would have to wait longer to get this taken care of.

Attorney Auffredou said it was a fair statement that Councilman Kusnierz made, but everybody would like to get going on this June 15th and have the traffic engineer there to assist and identify the scope of the study. If we wait it will be July until we can have a scoping session.

Councilman Kusnierz said he has a serious problem being asked to spend just under \$10,000.00 whether it is taxpayer dollars or funds coming out of Trust & Agency when there isn't any dialogue between the Planning Board and Town Board other than the info placed in this box the first of June.

A motion was made by Councilman Cumm to engage the services of TVGA for a traffic study to be paid out of Trust & Agency for the Pilot Travel Center Project not to exceed \$9,500.00.

Joe Patricke stated it isn't a traffic study. They are going to review what their consultant is proposing.

Councilman Kusnierz asked why we wouldn't expend funds to have our own study done independently rather than have somebody review a study done on behalf of a client.

Attorney Auffredou said the Planning Board has the discretion to do that, but they aren't there yet. What they have traditionally done is hire a consultant to review the applicant's. If the Planning Board decides they want their own traffic study done they can commission that work to be done.

Councilman Kusnierz said if we move ahead with this we could also ask for an additional independent study to be done on behalf of the Town to be paid for out of the Trust & Agency Fund.

Attorney Auffredou said that would be up to the Planning Board to decide if they want that done or not.

Councilman Kusnierz said to expend funds it would need Town Board approval.

Attorney Auffredou said understood, but that is a foggy issue as to what the Planning Board can do and what the Town Board can do.

Supervisor Jenkins asked if the group doing the traffic study will be discussing with NYS DOT the planned projects for next year as part of the traffic study.

Joe Patricke replied yes. That is what the scoping session will be about. They are outlining what they want the applicant's traffic study to include.

Supervisor Jenkins stated he spoke with a NYS DOT representative about whether or not they would accept a traffic light at Pilot across from Valero and they indicated that they would wait for the outcome of the traffic study.

Councilman Kusnierz said a matter that will have a significant impact on the Route 9 corridor should have an independent traffic study done by the Town and paid by the Town that we would bill back to the Trust & Agency.

Councilwoman LeClair seconded the motion.

A regular meeting of the Town Board of the Town of Moreau was held on June 9, 2009 in the Town of Moreau Office Building, 61 Hudson Street, South Glens Falls, New York.

Councilwoman LeClair recalled attending a county program meeting and discussion about county money that may be available for a traffic study. If an applicant pays for a study and the Town isn't comfortable with that study or wanted something done additionally there could be county funds available.

Joe Patricke didn't recall this and didn't think the county would pay for something like that.

Councilman Kusnierz asked which Trust & Agency account this would be paid from and how much money is going in.

Joe Patricke stated that an account isn't set up yet. We needed to know the amount before we could tell them how much to put up. They are aware of this proposal and they are willing to forward the money as soon as they are given the amount and the Board approves it.

Councilman Kusnierz asked if the Town could be on the hook for this expense if the applicant doesn't want to pay for it.

Attorney Auffredou said potentially yes, but the money is always in the account before we move forward with it.

Joe Patricke stated we will have the money prior to the signing of a contract.

Councilman Kusnierz asked why we wouldn't follow typical procedure and be sure the money is in the fund.

Attorney Auffredou replied, because the Supervisor isn't going to sign the contract until the funds are in the account.

Roll call vote on the motion and second resulted as follows:
